Eagle/Lake Student Pass Benefit Information

- Pass valid at Vail and Beaver Creek with no restrictions.
- Prices are valid all-season and the passes may be purchased anytime during the season.
- If any eligible student has already purchased another pass and wishes to exchange their current pass, we will gladly accommodate those requests, without penalty, at the Vail or Beaver Creek pass office.
- These pass products can **only** be purchased at the Vail or Beaver Creek pass offices. The Vail/Beaver Creek pass offices will open in November to fulfill pass sale, please call us at (970)Ski-Vail (754-8245) for pass office hours of operation.
- Both EC/Lake School pass types come with 6 Ski With A Friend Coupons that may be used to pass on discounted lift tickets to friends and family when the passholder is present.
- If the passholder wishes to ski at another Vail Resorts Mountain location, not included with their pass, the passholder will receive special discounts on lift tickets by presenting their EC/Lake Student Pass at the time of ticket purchase.

All students under 18 are required to have parent or legal guardian signature on release form.

As a reminder, season passes are for personal use only and may not be resold, exchanged, transferred, leased, or otherwise used for commercial gain. Violations of this restriction or other fraudulent use may lead to revocation of the season pass and reporting to local authorities.

Students who gain employment with Vail Resorts, Inc. will be eligible for a complimentary ski pass, complimentary ski lessons and additional benefits.
