What is World Academy?

Welcome to World Academy Online School! World Academy is a Kindergarten through 12th grade online program that aims to provide students who are looking for a unique learning path with a self-paced, challenging core content curriculum. Many children simply cannot get the focused and flexible learning they need in a traditional classroom setting. World Academy provides engaging content, individualized learning plans, and instructional coaches, delivered through cutting-edge technology and old-fashioned human interaction.

World Academy partners with Edgenuity for students in K-12.

Learning Labs*

To be successful, we recommend that students apply themselves about 5 hours per course per week. This will help them to stay on track until they get a feel for the program and the time that needs to be dedicated for success. The best part is that the learning moves at the pace that the students do. It doesn't move on if you miss a day and it never slows you down.

World Academy has two learning labs available for students and attendance is expected.

Learning labs have a licensed teacher on-site to provide guidance to World Academy K-12 students. World Academy follows the same calendar as Eagle County School District high schools. Please check our district-wide calendar at our Eagle County Schools website.

***Note that Learning Labs will need to be offered virtually until deemed appropriate due to Covid-19.**

Expectations

From our experience, we know the value of the learning labs and their connection to student success. Students are expected to make frequent check-ins with their teachers and counselor for support in the program. Our expectation is that students make contact with their teachers every 2 weeks to discuss instructional needs, coursework, pacing/progress, and assessments. Interactions with your instructors is crucial in building relationships and getting the support many students need in an online program.

When students come to the learning lab, we want their time to be productive and meaningful. Students are encouraged to ask for help and build relationships with their teachers as well as other students. However, the purpose of each lab is to be a beneficial learning environment that supports the needs of different types of learners. Students are welcome to bring headphones to listen to music, and technology such as cell phones need to be used responsibly. As we do not follow a formal bell schedule, students are encouraged to take brief breaks when needed (sign out with instructor). We ask that students are respectful of each other and schools with whom we share space and keep learning as your focus.

Attendance will be tracked weekly and updated in PowerSchool. Students failing to log-in over the course of week will be considered absent.

Signing In/Out

Students are expected to sign in and out with the instructor when they are in the learning labs. If a student needs to leave early, we ask parents/guardians to please contact the school.

Grade Policy and Schedule Changes

Grade Point Average and Class Rank

World Academy calculates grades for all classes by assigning an A, B, C, D, or F. Grades are figured into the grade point average at the end of each semester. World Academy will calculate GPA grades needed for college entrance and provide class rank.

Student Progress

Progress reports are emailed to the address we have on file weekly (please make sure this is updated in PowerSchool). Report cards are emailed at the end of every semester to give students and parents an indication of progress in each course. Official grades are entered onto the transcript at the end of each semester. Teachers can be contacted at school for more information on individual student progress. PowerSchool will be updated weekly.

Teachers are required to give regular and consistent feedback to students as they complete assignments. This feedback should feed forward and include strengths of student work, as well as areas of improvement.

Teachers are expected to initiate contact with the students when they demonstrate reluctance to begin a new task. At this point the teacher should evaluate if the student is struggling with the content and requires more direct instruction.

Schedule Changes

Families need to contact Troy Dudley regarding schedule changes.

Incompletes

We do not have incompletes at World Academy. If a class is not complete by the deadline, a NC will be issued and the student will be able to either retake the class or complete credit recovery.

Deadlines

Students are expected to complete assignments before the deadline assigned in the course by the online platform. Any assignment not completed before the deadline will be graded as is.

Unlocking Assignments

The online system “locks” the assignment after several attempts. In order for a student to redo the assignment, the student must contact the instructor of the class, explaining why you would like the assignment unlocked. Unlocking assignments is at the instructor’s discretion. Our goal is to ensure students complete the assignments before the due date to stay on pace with the course.

Credit Recovery Policy

1. It is credit recovery, not grade recovery. The previous grade will remain on your transcript.
2. If you are doing a credit recovery class to recoup credit from a World Academy class, then the original grade will be removed from your GPA calculation, but will remain on your transcript.
3. We are unable to change grades from other schools.
4. To recoup credit from a World Academy class, you will be enrolled in the course again. You will initially take pre-test and the program will assign, based on your score, what you need to complete for the credit recovery.
5. Once the credit recovery class has been passed, it will show up on the transcript as “CR [name of class]” and will show a “P” for pass and the credit.
6. If you choose to complete all of the credit recovery class (e.g. retake the entire class), you will receive the grade on your transcript under “CR [name of class]” and not just a “P” for pass.
7. Once you have completed the credit recovery class and passed, the “F” from the other class will not be counted in your GPA.

Edgenuity Grade Meaning

1. **ACTUAL GRADE:** Represents the overall grade adjusted for progress. If a student is behind in a course, the Actual Grade factors in zeroes for any late assignments. This grade will be lower than the Overall Grade if your child is behind in the course; it will be the same as the Overall Grade if your child is on time or ahead of schedule in the course. This is what goes into PowerSchool.
2. **RELATIVE GRADE:** Represents the grade that your child would receive if he or she stopped working in that course today and received 0% for all unfinished activities.
3. **OVERALL GRADE:** Percentage grade based on a 0%–100% scale. This is how your child is scoring for the assignments they have completed.

Graduation Requirements

In accordance with Eagle County School District policy, to receive a diploma from World Academy Online School, students **MUST** earn a minimum of the following credits to graduate. Each semester class is worth 0.5 credits.

Classes on Transcripts

On World Academy transcripts for 9th-12th grade students, per NCAA requirements, they need to be labeled as “online”. You will see classes written as “online XYZ” class.

PE Logs

All students are enrolled in the World Academy PE Fitness Log class. Here is a video about how to use the PE Fitness log: https://www.youtube.com/watch?time_continue=1&v=IFAmiX7KU0o&feature=emb_logo. All students are required to complete 60 hours of P.E. credit per semester. Grades will be calculated based on how many hours (EX: if a student only completes 52 hours, then it would be $52/60=87\%$ for the class). For every 60 hours of physical activity (if you are in high school) you may receive a 0.5 of credit.

Pre-Collegiate Curriculum

The Colorado Commission on Higher Education has established high school requirements for all students entering any of the 14 Colorado, Public, 4-year institutions in order to ensure success in

the college setting.

Minimum Colorado College and Career Ready Determinations

To earn a diploma approved by the Colorado Department of Education, a student must prove college and career readiness by demonstrating competency in core subjects using criteria established by the Colorado Board of Education.

The state's minimum College and Career Ready Determinations for English and Math are set to match proficiency levels on higher education's cut scores for placement in credit bearing classes, industry certificates, and the military's cut scores for academic consideration for preferred career training. They are designed to be of approximate comparable rigor and will be

refined, improved, and added to over time.

Students must demonstrate competency in each content area using any one of the items in the competency demonstration menu for that content area. Students wishing to attend four-year postsecondary institutions will also need to meet the entrance requirements for their institutions of interest.

¹ Capstone projects must be proven as: valid, comparable in rigor to the other choices, standardized in their administration, free from outside assistance, credibly judged by a third party and aligned to the standards. Specific rubrics for district use in each subject area will be created and verified among and between high school educators and pertinent, subject-specific industry and college advisors.

Note that the ACT, SAT, AP and college credit determinations are set at the spring 7 thresholds for “no need for remediation” as outlined in the Colorado Commission on Higher Education’s Admission Remediation Policy. These thresholds are under review and may be revised by CDE.

While no single competency demonstration in the above menu fully measures the new academic K-12 standards, the determinations begin the transition to a competency-based system. While not identical instruments, the menu of competency determinations shares thresholds of approximately comparable levels of rigor.

Determinations of competencies may be modified to accommodate students with exceptionalities (i.e., students with disabilities and students who are gifted and talented.)

College applicants have to be successful in rigorous coursework and have strong test scores.

Getting into College

Applying to college can be a daunting and overwhelming experience for students and their families. Please feel free to contact us for additional resources. Colleges report that the most significant factor in the college admission decision are the grades earned in classes in high school. Secondly, colleges review standardized admission test results. Most colleges require either the SAT or ACT. Colorado colleges use an index of GPA and test scores to determine admission to in-state, public, four year colleges. ALL Juniors in the state of Colorado are required to take the SAT test in April with no registration fee. These test results can be used to apply to colleges around the country but are not accepted for NCAA eligibility. Students may take either test more than once, however, more than three times is not recommended. Colleges also review essays and recommendations from teachers and counselors.

- Juniors enrolled in World Academy will be given a voucher that will cover the cost of one SAT exam. Vouchers will be handed out in the spring of junior year. It is the student's responsibility to sign up for the exam. Please visit sat.org for more information and to register for the exam.

College Credit Opportunities at World Academy

Students at World Academy can earn college credit while working toward high school graduation. Students benefit not only by saving college tuition and time, but will find upper-level courses challenging and a good preparation for college work. This includes opportunities such as dual credit courses and internship opportunities.

Taking College Classes in High School

Eagle County School District has entered into an agreement with Colorado Mountain College to provide the opportunity for students to earn high school and college credit simultaneously. ASCENT Program

ASCENT stands for Accelerating Students through Concurrent ENrollment. Students who have

completed at least 12 credit hours of postsecondary course prior to completion of his/her 12th grade year may be eligible for the ASCENT Program. They remain students in their Local Education Provider (LEP) for one year following their 12th grade year, and the LEP receives ASCENT specific per-pupil state funding that it uses to pay their college tuition at the resident community college rate. Students receive their high-school diplomas at the end of their ASCENT year.

1. Eligibility

Students who wish to enroll in the ASCENT Program must have fulfilled high school graduation requirements; completed or be set to complete 12 credit hours of transcribed college course work; be identified as an ASCENT program candidate on an Academic Plan recorded within the district; be no more than 21 years old; and meet the College's requirements for each course.

2. Enrollment

ASCENT covers only postsecondary courses offered by the College, in which high school students will be permitted to enroll pursuant to the ASCENT Program. The College agrees to enroll Local Education Provider's students in courses offered by the College as follows:

- a. The courses offered by the College must be applicable to earning a degree or certificate.
- b. Students may not enroll in College basic skills courses through the ASCENT Program.
- c. The College has the right to deny student enrollment based on space availability and college admission requirements.
- d. The College has the right to discontinue a student's enrollment based on a determination that the student does not have sufficient skills or abilities to continue in the course selected. In such case, the College will notify the Local Education Provider.
- e. Students enrolled in College courses through the ASCENT program are subject to the academic and disciplinary rules of the College's Student Code of Conduct and adhere to all College policies and procedures. Any violations of the Student Code of Conduct are subject to disciplinary proceedings and sanctions.
- f. Students in need of accommodations are encouraged to contact the College's office assisting with special services.
- g. The College is responsible for the course content, course prerequisites and quality of instruction.

3. Credit

A student who is accepted in the ASCENT Program shall receive postsecondary credit toward a degree or certificate and credit toward high school graduation as follows:

- a. Students shall not enroll in a basic skills course.
- b. Unless otherwise restricted, students are not limited in the number of credit hours in which they concurrently enroll through the ASCENT program.

4. Registration

- a. All students shall enroll and register as College students in accordance with College's admissions and registration requirements and processes.
- b. Districts should enroll students in College courses that pertain to the degree or certificate program indicated on their Academic Plan.
- c. Academic advising and career planning will be available to students at both the College and the Local Education Provider.
- d. All students shall complete the Concurrent Enrollment Registration and Agreement Form and submit to the College by the course census date.

5. Financial Provisions/Tuition

The tuition and fees charged by the College for students enrolled in the ASCENT Program will be as follows:

- a. The Local Education Provider agrees to provide the College with each student's uniquely identifying student number (SASID) which will be used to authorize College Opportunity Fund (COF) stipend payments to the College on behalf of the enrolled student.
- b. The Local Education Provider hereby agrees to pay the College on behalf of the student.

Business and School to Career

Business education provides business and computer information, and skills to enhance every individual as a citizen and a consumer. Business education prepares students for entry into, and advancement in jobs within business, computer, and many other related career areas. It also prepares students to handle their own business affairs and to function intelligently as citizens and consumers in a business economy. World Academy will only accept School to Career/Work Study, Community Service, and Internship/Apprenticeship hours while you are a student at World Academy. Hours earned before entrance will not be accepted.

School to Career and Supervised Work Study

This course is a supervised work-study opportunity for World Academy students. Students can earn .50 credits for a minimum of 120 hours of paid employment during the school year and summer. Students will be supervised and are expected to verify their work hours and further develop their career portfolio.

Community Service

Students may perform community service. This is defined as donating time to a worthy or charitable organization throughout the local community. These are unpaid hours donated in service to an organization. Students need 60 hours of community service equals .5 credits of elective credit.

Internships/Apprenticeships

Students are encouraged to participate in internships or apprenticeships. This is defined as donating time to a working organization or business throughout the local community, which is of direct interest as a potential career for a student. These are unpaid hours donated in service to the organization while learning the trade in exchange. Students need 60 hours of internship/apprenticeship equals .50 credits of elective credit.
